When you make this transfer, please state the year for which you are paying and your membership NAME and NUMBER. Should you not know your membership number, it can be obtained from your NatRep or the Secretary.

At the recent Plenary Meeting on 25 October, It was pointed out that the current ANARCP Bye-Laws reads:

**“Section 1.5.:** Membership shall be lost:  
By non-payment of the membership fee within one year after it is due;  
**Section 6.2.** Annual membership fees fall due on 1 January of each year.”

It was agreed that this could be detailed with more clarity. The Secretary also suggested that the timelines for annual payments should be clarified as:

- Nov – Dec (Year -1) – NatReps remind chapter members that payment for the coming year is due in the New Year and that payment should be made by 1 June.
- Apr (Year) – Send out reminders.
- 31 May (Year) – Final date for payment of dues.
- May (Year) – Coordinate with Treasurer and update the Plenary meeting on chapter payments.
- Oct (Year) – EXCOM is updated, review/approve suspension list.
- Jan - Mar (Year +1) – Secretary sends out suspension letters, copy to respective NatRep.

A change to the Bye-Laws will be proposed to the members to reflect the above timelines. The Secretary agreed to action this and a change to the ANARCP Bye-Laws will be proposed in the next Bulletin. It will also be placed on the agenda of the 2018 Annual General Assembly for formal adoption by the membership.

### **Confederation**

The Executive Committee of the Confederation is taking on more responsibilities from the composite associations. The Executive Committee of the Confederation of NATO Retired Staff Associations (CNSRSA) consists of four members designated by each of the four retired staff associations. The four members for the ANARCP are: Peter Ludford; Laurie Daykin, Jean Vanderwal and Hessel Rutten who has recently been elected Chairman.
